**COUN R5813 Advanced Counseling Approaches and Group Techniques: School Counseling Residency**

This second residency course includes an online courseroom and a face-to-face residency experience. Learners engage in online courseroom activities to prepare themselves for the face-to-face experiential component and residency experience that guides them as they integrate school counseling theories and methods with counseling practice. In addition, this residency provides 10 hours of group experience.

**COUN 6102 School Counseling Practicum**

Capella University *July 2019 – June 2021*

*Course Description*

This course is a supervised site-based experience during which you will practice specific counseling skills, including interviewing, assessment, intervention, documentation, and consultation in a school counseling field setting. This course includes 100 hours of on-site field experience, including no less than 12 hours of face-to-face supervision with site supervisors. In addition to the 100 hours required, learners participate in 15 hours of group supervision.

**COUN 6131-32 School Counseling Internship**

Capella University, *July 2019 – June 2021*

*Course Description*

This course is a supervised site-based experience in which students apply counseling skills, prevention strategies, and crisis intervention strategies in a supervised field setting. This internship requires 600 additional hours of field experience. Therefore, to complete an internship, you are required to collect 600—240 hours of direct contact with at least 10 hours facilitating group counseling, 24 hours of supervision at the site (at least 12 hours per quarter), and the remaining 336 hours, which can be indirect. Typically, this is done over two quarters.

**ECD 642 Practicum in Counseling**

North Carolina State University, *January 2016 – May 2016*

*Course Description*

This course is the third component of the Department's clinical experience sequence in the application of counseling theory. The course is a supervised practicum experience offered in several individual seminar sections, which focus on case conceptualization, client assessment and evaluation, oral and written case reporting, and the overall evaluation of counseling performance in individual and group interventions. This course aims to allow participants to further develop their skills in individual Counseling, group work, and consultation while under direct supervision.

**ECD 510 Orientation to Counseling Profession**

North Carolina State University, *May 2016 – June 2016*

*Course Description*

The course integrates the use of face-to-face instructions and online instructions, which includes narrated presentations, digital film demonstrations, student-teacher interactions through face-to-face meetings, and assignments, both online and during on-campus instruction. This course is demanding given the hybrid nature (i.e., face-to-face and online components) and the 5-week duration.
